A single asterisk '\*' next to a "YES" or "NO" answer is used to indicate the candidate included a comment. A double asterisk '\*\*' next to a "YES" or "NO" answer indicates the candidate declined to respond to the questionnaire, but their position was derived from other resources, including legislative records, endorsements, past questionnaire answers, or public records. - 3. Tax Kicker. Do you support or oppose the tax kicker law that returns over collected taxes to taxpayers?
- 4. Healthcare. Do you support or oppose state-funded healthcare for all?
- 5. School Choice. Do you support or oppose the use of school vouchers for *K-12 grade education?*
- 6. **Education.** Do you support or oppose *lowering high school graduation standards?*
- 7. **Police.** Do you support or oppose partially or fully defunding police departments?
- 8. *Liberty.* Do you support or oppose including religious exemptions in legislation to prevent restrictions of religious freedom in hiring and insurance mandates?

# BALLOT Measures

Welcome to the Oregon Family Council Voter's **Guide Ballot Measure** section. Here you'll find information on each of the four statewide measures that will appear on your 2022 General Election ballot. We've also included an **OFC** recommendation on how to vote and a helpful commentary on each measure's strengths and weaknesses.

We hope this guide will be a valuable supplement to other information sources in deciding how to vote.

#### IT'S OKAY To disagree

Many of the ballot measures we are asked to vote on this year are very complex. We have done our best to provide sound reasoning for the positions we have taken.

And while we provide a recommendation on measures, the last thing we want is to imply that these positions are the only ones Christians should take. Differences are okay and to be expected, particularly when it comes to applying the principles of the Bible to complex public policy issues.

We implore you to be careful and prayerful about the use of this Voter's Guide, and we encourage you to utilize other information sources. Most importantly, we urge you to vote. Your vote makes a difference.

# MEASURE 111

**Amends Constitution:** State must ensure affordable healthcare access, balanced against requirement to fund schools, other essential services.

#### **\*** OFC RECOMMENDATION

#### **NO** We recommend a "No" vote.

#### **OFC EXPLANATION:**

This constitutional amendment requires the state government to ensure that every resident - regardless of whether or not they are a citizen - receives affordable healthcare. The measure does not specify how such care is funded.

#### **OFC COMMENTARY:**

Measure 111 certainly sounds reasonable on the surface. Who doesn't want every person to have the ability to access needed healthcare services especially with ever-rising healthcare costs? But our concern is that Measure 111 will make the current problems we face worse, not better. To begin, providing adequate education and public safety are currently NOT constitutionally required. However, healthcare would become a constitutional right if Measure 111 is passed. This obligation would be funded at an extraordinary cost, resulting in increased taxes on employers, employees, goods and services, or likely all of the above. Another grave concern is that the state government will define what, and what does not, constitute healthcare. In Oregon, that will certainly include abortion, gender transition, and other morally questionable procedures. Finally, Measure 111's title is "Right to Healthcare Amendment". Constitutional rights limit government from infringing on individual rights, not guarantee they are provided. For example, the 1st Amendment protects our religious liberties but doesn't require the government to build our churches. The 2nd Amendment protects the right to own firearms, but the government doesn't provide every citizen with a gun. Finally, experience has demonstrated time and again that government control leads to inefficiencies, increased regulations, increased costs, and ultimately authoritarianism. We recommend a NO vote.

# MEASURE 112

Amends Constitution: Removes language allowing slavery and involuntary servitude as punishment for crime.

**\*** OFC RECOMMENDATION



#### OFC EXPLANATION:

The Oregon Constitution strictly prohibits slavery or involuntary servitude. The one exception is for those serving time in prison. Measure 112 would remove this exception along with any requirements for inmates to work while imprisoned.

#### OFC COMMENTARY:

Let us be clear: Slavery is an evil. Our nation has a history that includes the ugliness of slavery in its past. Today, we still have those who unlawfully traffic the vulnerable in the sex trade and other forms of forced labor. We agree there is great value in adjusting the language of our laws and public policies to reflect our strong opposition to slavery. More specifically, we recognize that there are times that work environments in our prisons can be coercive. Even with this concern in mind, there are pitfalls that accompany removing all work requirements from those serving time in prison. Oregon law stipulates that working inmates are to receive hourly wages comparable to non-inmate workers doing the same work. Along with earning money and developing employment skills, working inmates can be rewarded with shortened sentences for faithful job performance. Additionally, working inmates perform important prison tasks like working in the laundry room, kitchen, library, or janitorial services. Furthermore, it is well documented that prisons lacking in meaningful work programs have higher incidences of prison violence. And let's not forget that our nation has strayed far from a biblical system of criminal justice which emphasizes restitution by offenders to their victims. Removing all work requirements for inmates will cause that system to stray even further. For this reason we lean toward a NO vote.

# MEASURE 113

Amends Constitution: Legislators with ten unexcused absences from floor sessions disqualified from holding next term of office.

**\*** OFC RECOMMENDATION

#### NO We recommend a "No" vote.

#### OFC EXPLANATION:

This constitutional amendment would punish a state representative or state senator who misses ten floor sessions during a legislative session by preventing them from serving in the future. Measure 113 is a response to a tactic used by the minority party to prevent a vote when a two-third quorum is required to conduct business.

#### OFC COMMENTARY:

In our nation, elected officials represent the citizens in the district they serve. As citizen taxpayers, we pay the salaries of our duly elected government leaders, and it is only right that we require them to show up to work. It is important to understand that Measure 113 is not designed to discipline a lazy representative who refuses to work. A single representative's absence cannot prevent a quorum. Absence from floor sessions is coordinated by the whole of the minority party. In Oregon, the Democrats hold a super majority. That means Democrats have the power to pass any law - even large tax increases - without any input from their Republican counterparts. Coordinated non-attendance is the only option available to prevent the majority party from "bulldozer" lawmaking. To gain a quorum, coordinated non-attendance requires the majority party to come to the table and negotiate with the minority party. If passed, Measure 113 punishes the members of the minority party - in this case Republican legislators. By banning these representatives from holding office, Measure 113 additionally removes the right of citizens to elect the kind of courageous leadership who will stand for minority rights. We urge a No vote.

# MEASURE 114

Requires permit to acquire firearms; police maintain permit/firearm database; criminally prohibits certain ammunition magazines.

**\*** OFC RECOMMENDATION



#### OFC EXPLANATION:

Measure 114 creates a host of requirements for citizens to lawfully purchase, sell, or own a firearm. These include a gun permit, expanded background checks, a gun use class, and inclusion in a searchable database. It also bans magazines holding more than ten rounds.

#### OFC COMMENTARY:

As citizens, we accept licensing and training requirements for some privileges. Obtaining a driver's license is one example. Firearms by their nature can be dangerous, and they are used by wrongdoers in committing crimes. Therefore, reasonable requirements are understandable. But Measure 114 goes beyond reasonable in what its requirements define and do not define. Permits are required but may be denied. The criterion for denial is not clear. Currently background checks must be completed within ten days, but Measure 114 has no time limit. An extensive training class is required, but cost and availability of those classes are undefined. Owning a firearm - whether for hunting, recreation, or personal safety - is a right guaranteed by the US Constitution. The Bible itself affirms the right to self-defense. Due to potential excessive costs or regulatory hurdles, Measure 114 may prevent many law-abiding Oregonians from obtaining a firearm. Furthermore, many guns - including many common shotguns - would be outlawed. Additionally, the cost of implementation both for background checks and classes will run in the hundreds of millions. Not all of these costs are covered in fees, thus taking money from already underfunded law enforcement. Finally, according to the US Department of Justice, less than two percent of prisoners in federal custody obtained the gun they used in a crime from a legal retail source. This suggests that Measure 114 will add greater burdens upon law abiding citizens while doing little to impact criminals. We lean toward a No vote.
